Avoid having to download, email, or print statements that may get lost or stolen. The source data is directly from the bank for a faster response time and greater accuracy.

Getting started is easy

Your auditor will email you an invite to initiate the process, then simply:

1. Open the Account Consent Requested email to verify the requested information
2. Click the authenticated link to provide consent
3. Review the pre-populated form and select your bank
4. Proceed

Immediately, the data securely passes from the bank to the Open Banking platform to be viewed by your auditor. Most auditors will get 365 days of transaction history.
